BOROUGH ASSEMBLY
(All offices serve at-large)

Seat D – 3-year term
Incumbent: Christopher Quist

Seat E – 3-year term
Incumbent: Guy Sattley has termed out

Seat H – 3-year term
Incumbent: John Davies has termed out

Assembly Qualifications. Candidates for borough assembly must:

- Be a qualified voter of the state of Alaska at a residence within the borough.
- Have resided within the borough for a period of one year preceding filing for office.
- A person shall not occupy or be a candidate for more than one elective seat at a time.
- Meet requirements as set forth in FNSBC Title 5.

Elections for these positions are conducted at large by all qualified voters of the borough.

Terms: The term of the office for borough assembly is three years or until a successor is elected and qualified. Service is to begin on the first Monday following certification of the election.

A person who has served two full successive terms may not be reelected to that elective office or body until one full year has intervened.

SCHOOL BOARD
(All offices serve at-large)

Seat E – 3-year term

Seat F – 3-year term
Incumbent: Sean Rice

Seat G – 3-year term
Incumbent: Wendy Dominique

School Board Qualifications. Candidates for school board must:

- Be a qualified voter of the state of Alaska, and a municipal voter in the school district
- A person shall not occupy or be a candidate for more than one elective seat at a time
- Meet requirements as set forth in FNSBC Title 5.

Elections for these positions are conducted at large by all the qualified voters of the borough.

Terms: The term of the office is three years and until a successor takes office as set forth in AS. 14.12.050.

INTERIOR ALASKA NATURAL GAS UTILITY BOARD (IGU)

At-Large Seat C - 3-year term
Incumbent: – Jack Wilbur

At-Large Seat D - 3-year term
Incumbent: – Aaron Lojewski

IGU Board Qualifications. Candidates for IGU board at-large seats must:

- Be a qualified voter of the state of Alaska at a residence within the borough.
- Have resided within the borough for a period of one year preceding filing for office.
- A person shall not occupy or be a candidate for more than one elective seat at a time.
- Meet requirements as set forth in FNSBC Title 5.

Elections for these positions are conducted at large by all qualified voters of the borough.

Terms. The term of the office for the IGU board member is three years or until a successor is elected and qualified. Service is to begin on January 1st following certification of the election.

A person who has served two full successive terms may not be reelected to that elective office or body until one full year has intervened.
